SLIP AND FALL ACCIDENTS

With winter upon us, slip and fall accidents are on the rise. A person will also sustain different types of injuries as a result of their fall. In the event, that someone has suffered injuries as a result of a slip and fall accident, there are several things that they should do to protect their future.

When a person has been involved in a slip and fall accident and has sustained an injury or injuries, it is imperative that they seek medical attention immediately. Although the person may have gone to the hospital following the accident, it is also essential that they follow up with their family doctor. Not only is it important that there is medical documentation about the fall, but it is also the person's responsibility to seek proper medical treatment for any injuries they sustain in the accident.

There are other things that an injured person should do immediately following, or as soon as possible, after a slip and fall accident. This includes taking photographs of the area where the fall took place and photographs of any injuries sustained as a result of the fall. If there is a possibility that the fall took place on municipal or city property, it is crucial that the municipality or city is notified of your fall in writing within seven days of the accident. It is also important that you notify your collateral benefits insurance company of your fall to ensure that you get assistance with any treatment you will require for your fall.

If you are injured in a slip and fall accident we strongly recommend that you contact a personal injury lawyer immediately to ensure your future is protected.
